SUBJECT: Bell Schedule School Stakeholder Group Results

Background

- To optimize operational, instructional, and overall organizational efficiency, Hillsborough County Public Schools (HCPS) began exploring bell schedule options for the 2017-2018 school year in August 2016.
- This group met several times during the 2016-2017 school year to consider the implications of these changes and identify the bell schedules that would help mitigate operational issues while allowing maximum instructional benefit for students.
- In March 2017, additional stakeholder input about these plans was sought through school-based stakeholder groups among staff, students, and parents.
- Some 22 schools were asked to facilitate stakeholder groups among these 3 groups and summarize the input received by Friday, March 31, 2017. These groups included:

- In total, 1,310 people participated in the stakeholder groups. There were 227 student participants, 930 staff participants, and 153 parent participants.

Script Design and Data Collection

- During the stakeholder groups, the facilitator used a script to guide the group and recorded the input received using a data collection tool so that feedback could be gathered systematically across schools and groups (see attached).

- The data collection tool asked the facilitator to record the date and time of the stakeholder group, number of people attending, HCTA and HSEF representatives participating, representativeness of the groups in terms of gender, race/ethnicity, socio-economic status, transportation methods currently used, and age, as well as their awareness of the school's current bell schedule (see attached).

Stakeholder Group Findings

- Themes and concerns noted by participants included:
 - Staff Meetings
 - Similar impact to parents since many staff have students attending district schools.
 - Affects work time, break time, transportation plans, day care needs.
 - Coaches are unsure when they would have practices.
 - The proposed elementary start time allows them to be at bus stops in daylight hours.
 - Not sure about getting to work on time after dropping off students.
 - This will influence whether teachers are willing to stay after school and other meetings.
 - Athletic events will be even later. Will students be supervised on campus before games?
 - Will busses still be late getting to and from school anyway?
 - Eating lunch at 10am on early release days is a challenge.
 - Will students get enough sleep?
 - Some staff are concerned about new schedule and impact on instructional time and student contact.
 - Teachers like having more planning time.
 - Influence child care logistics and costs.
 - It is always difficult to schedule doctor appointments and extra-curricular activities.
 - Traffic may be different with new schedule. Has anyone looked at data? Earlier starts mean off-peak travel for many.
 - Many students tardy at 8:00 start time, so this might help them with attendance and engagement.
 - More planning time is needed.
 - Forces people to pay for childcare/HOST and creates added expense for families.
 - Do not want to get home at 5:00, especially when it is dark at this time
 - Hard to coordinate travel for families with multiple start times
 - Student Meetings
 - Busses pick up students too early.
 - I oversleep and don't get there on time.
 - We already have to rush in the morning.
 - I miss the bus.
 - Students forced to go to HOST so that parents can get to work on time.
 - HOST doesn't give enough emphasis to getting homework done. Needs to have options for less social time.
 - I like the schedule now because I can do things after school.
 - Students involved in extra-curricular activities and challenging academic programs are up late getting homework done and don't get enough sleep.
 - If the bus is late, I am late.
 - I skip breakfast so I can be on time.

- Parent Meetings
 - It may be difficult to get to and from work with the new schedule.
 - Change is hard when routines are already established.
 - Influences working hours and I am not sure I can adjust.
 - Concerns about what time students would have to wake up
 - Juggling schedules for families with students on different schedules
 - Magnet bussing limitations for parents
 - Creates a cost burden of before/after school care
 - Staggering needs to be in place. Hard to get all students to school on time when start times are so close together.
 - Less opportunities to be involved in extra-curricular activities for students getting out of school late.
 - Lack of activity/exercise for students
 - Hard on single-parents
 - Start times are too late for working parents.
 - Lack of sleep and exercise impacts student health.
 - Many parents prefer that students get out earlier (like early release once a week).
 - Large families will have a hard time getting 3 or more children to school.
 - School schedule will influence where I can work and still get my children to school.
- When asked if the current bell schedule was convenient, participants noted:
 - Staff Meetings
 - Mixed opinions about the current bell schedule were given. Elementary staff felt the current schedule was convenient, but middle school staff felt their current bell schedule was not convenient for after school commitments.
 - Student attendance under current start times can be a challenge when instruction is missed on a regular basis.
 - High school passing time is a concern because it may be too long or too short in some instances.
 - More planning time would be great.
 - Middle school students lose focus in late afternoon and instruction is more challenging later in the day.
 - Traffic for those commuting long distances can be a challenge as it is unpredictable.
 - The impact of late busses on the current schedule is hard for teachers.
 - Would it be feasible to provide free or discounted HOST to staff before school?
 - Student Meetings
 - Students who ride the bus sometimes don't make it to work on time and lose jobs.
 - Student participants were split about waking up early and finishing early versus being able to sleep later and get home later.
 - Traffic gets worse the later in the day we are at school.
 - Parents have to pay for HOST, which is hard.
 - Hardships for parents who work shift hours that are not close to bell schedule.
 - Hard to schedule appointments or activities after school for middle school students.
 - Do not like when bus delays cause them to get home later than usual.
 - If we have to eat breakfast at school, having more options would be great.
 - Students like early release one day per week.

- Parent Meetings

- Many participants said they will deal with whatever is decided.
 - Concerns about work schedules and flexibility with jobs given the new bell schedules.
 - Hard for working parents to be involved in school events with these times.
 - Overall, the current bell schedule is good, but magnet bussing and late end times encroaching on student extra-curricular activities were concerns.
 - Parents whose students are on multiple schedules struggle.
 - Hard to drop students off before work if start time is before 8:00 AM.
 - Current schedule allows students to schedule appointments, participate in extra-curricular activities, complete homework, etc.
 - Transition from elementary to middle would be easier if start times were more similar.
 - HS and MS schedules are too far apart right now.
 - Proposed schedules allow for more sleep and more time to get students ready in the morning. However, many felt that the start time would make it hard to get to work on time and would increase childcare costs.
- Better communication about these changes, with more time for input would have benefitted parents and staff.
 - Concerns about transportation, childcare, getting to work, and timely access to information were most commonly cited.

2017-2018 BELL SCHEDULE STAKEHOLDER GROUPS

To optimize operational and instructional efficiency for the 2017-2018 school year, there is a need to consider revised bell schedules for elementary, middle, and high schools. Both the quality of instruction and the efficiency of school operations are important influences on the decision.

As such, input from a variety of stakeholders should be obtained at each site about current and potential bell schedules to inform decision making and ensure consideration of parents, staff, and students.

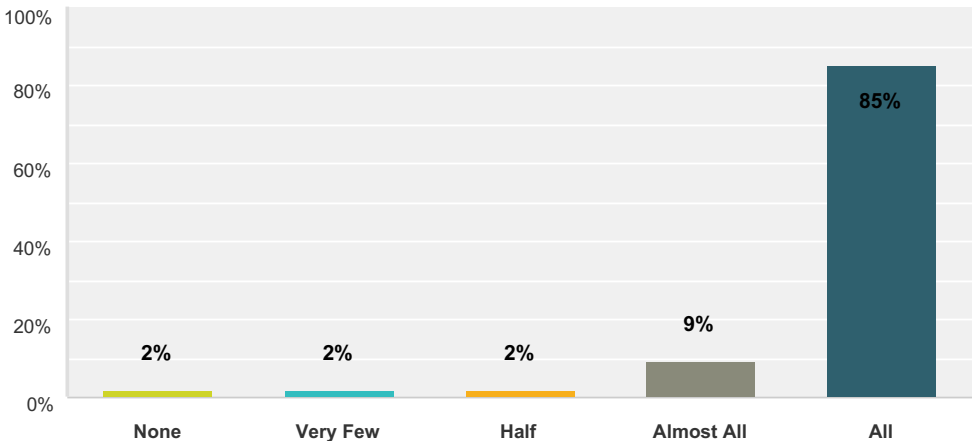
