Dear Parent,

Transportation often presents some difficulties for families at our schools. To alleviate some of these difficulties, we are working with the Tampa Bay Area Regional Transportation Authority (TBARTA) School Pool Program to provide free carpooling matching assistance for families who are interested in sharing rides to and from school. We are including this program in your child's magnet school.

Interested families who complete the School Pool registration will receive a list of names and phone numbers (Match List) of families from magnet school parents who live in your area and are also interested in sharing rides to and from school. Home address information is confidential and only the closest major intersections are included on the list. Families receiving a Match List are not obligated to school pool and can use the list as a backup in the event they have a temporary or sudden transportation need.

The School Pool program only matches families at the same school where other parents have registered. **The more families participating in the program, the better opportunity the School Pool program has to provide school pool matching!**

- 1) Fill out this form **completely**.

- 3) TBARTA will create a personalized match list of other families who live by you and who want to School Pool.
- 4) The School Pool Match List will be sent to the address provided on the registration.
- 5) When you receive your match list, call the families on your list to make arrangements. Because you are not obligated to form a School Pool, you may keep the list as a back-up in case your circumstances change.
- 6) After you find a rideshare match, be sure to register your School Pool by filling out a parent survey to let us know how it is working. Surveys will be available in the school office.
